**\$650** INFANT (UNDER 365 DAYS) MUST BE IN A CHERUB

\*ALL FORMS, PERMITS, ETC ARE THE RESPONSIBILITY OF THE APPLICANT.  
\*ALL DISINTERMENT/REINTERMENT FEES MUST BE PAID AT LEAST 24 HOURS IN ADVANCE OF THE DISINTERMENT/REINTERMENT.  
\*OUR FEE IS FOR CEMETERY CHARGES ONLY! ANY OTHER COSTS SUCH AS BUT NOT LIMITED TO FUNERAL HOMES, VAULT COMPANIES, AND MONUMENT COMPANIES ARE THE APPLICANT'S RESPONSIBILITY.  
\*ALL DISINTERMENTS MUST BE SCHEDULED AT LEAST FIVE DAYS IN ADVANCE.  
\*DISINTERMENTS/REINTERMENTS MAY BE POSTPONED AT THE DISCRETION OF THE CEMETERY.

**ALL COSTS FOR LOT SALE, OPENING/CLOSING, OR DISINTERMENTS WILL BE COLLECTED PRIOR TO INTERMENT/DISINTERMENT. NO CREDIT WILL BE EXTENDED UNDER ANY CIRCUMSTANCES.**

## FONDULAC CEMETERY RULES AND GUIDELINES

**SPRING CLEAN UP – MARCH 1<sup>ST</sup> (weather permitting)**

**FALL CLEAN UP – NOVEMBER 15<sup>TH</sup> (weather permitting)**

- Holiday blankets are allowed from **November 15 to March 1**. After that time, they will be removed by the cemetery.
- NO Shepherd Hooks allowed.
- Floral and other artifacts and displays are allowed within one (1) foot of the headstone on the grave side.
- **The Fondulac Cemetery and/or Township is not responsible for lost or stolen flowers, artifacts or displays.**
- No bushes, trees, decorative rock, woodchips or fence will be allowed.
- Fondulac Cemetery reserves the right to remove any artifact from the grave, i.e. artificial flowers, stuffed animals, ribbons/bows, dead/overgrown plantings or other items which are determined to be unsightly, broken or faded and present a detriment to the natural beauty of the Cemetery. **Cemetery staff reserves the right to use their discretion to make this determination.**
- No individual mausoleums or grave ledgers are allowed.
- Bench Monuments are allowed in lieu of a standard monument and must be placed at the head of the grave.
- Headstones, slabs and monuments which have fallen or which require repairing may be removed or the condition corrected by order of the Cemetery unless removed or repaired by the owner.
  
- Fondulac Cemetery may prohibit any contractor or workman from working in the Cemetery if such contractor or workman prove to be unreliable or incapable or if he/she refuses to abide by the rules and regulations.
- Private contractors and others will be held responsible for any damage done to lots, graves, paths, roads, plantings, trees, structures, etc., including damage to the lawn, and shall take all necessary precautions to avoid damage.
  
- Spreading of cremated remains will not be permitted. All remains must be interred in a solid container.
- Cremated remains will be buried by cemetery personnel ONLY.
- A limit of four (4) burials will be permitted on each gravesite. Only one (1) traditional (casket) burial is allowed in a grave.
- Unused graves may NOT be re-sold by an individual. They must be returned to the Fondulac Cemetery and the original purchase price will be refunded unless the purchase price was less than \$200. In that case, a minimum refund of \$200 will be given.
  
- **Hold graves:** An individual may place graves on hold for a maximum of 30 days. After 30 days, any grave not paid for may be sold by the cemetery.
- Residents of Fondulac Township may not purchase graves at the discounted price for the sole purpose of giving them to individuals living outside of Fondulac Township.
