Supervisor Report: Fondulac has seven precincts at three polling places – five in Folepi Building, one at Fondulac Park Building and one at City Building. Rick reported that Folepi had a lot of voters on November 5, 2024. Kindra and staff did a great job getting the facility set up. A thank you to Bret Tucker for getting ample space available for voters moving barrels and city vehicles out of the way. Steve Flinn is looking into chairs from ICC to be available for next election.
